# Rent Adjustment Program Follow-up Report

Today my Office issued the *Rent Adjustment Program Recommendation Follow-up Report.* The purpose of the report is to follow up on the implementation status of the 2016 previous audit report recommendations. Follow-up reports increase accountability by ensuring audit recommendations are fully implemented. The follow-up found:

3 out of 10 recommendations have been fully implemented and closed since the audit was issued in June 2016:

- 3 additional alternates have been added to the Board and now the Board can meet weekly,
- Petition hearing and Rent Board decisions are posted on the Program website,
- An audit was conducted to validate residential rentals properties' assessments.

6 recommendations have been partially implemented and 1 recommendation has not been implemented.

The Administration is committed to fully implementing all the recommendations by the end of the 2019-2020 fiscal year,

## **JUMPING IN FEET FIRST**

#### **Audit of the Police Commission**

Last Thursday my team and I presented our preliminary audit objectives to the Police Commission. Measure LL mandates that we conduct an audit no later than two (2) years after the City Council has confirmed the first set of Commissioners and alternates. The audit will cover the period of October 2017 through the end of fieldwork which is anticipated to be the end of July 2019. The preliminary objectives of the audit are to assess whether:

The Commission and the Community Police Review Agency (CPRA) adequately comply with Oakland Municipal Code requirements, specifically to determine if

- Reporting requirements are met and policies and procedures have been established and followed, and
- The Commissions' oversight role and the CPRA investigative processes are effective.

CPRA has established controls to properly manage investigations, specifically to determine if

• Public complaints are processed accurately, completely and timely and appropriately prioritized.
