# Whistleblower Program Annual Report Released


This week my Office released our Annual Whistleblower Report (Report) covering Fiscal Year 2020-21 (July 1, 2020 through June 30, 2021).

Notably, 214 complaints were filed in FY 2020-21, including allegations of misuse of City assets, wage theft, and larceny. A total of 238 cases were closed and 85, or 36 percent, were closed after an investigation.

The Report provides details about the whistleblower investigation process, the number and types of allegations submitted, the characteristics of the whistleblowers, the allegations that warranted investigation, and concludes with a summary of the investigation outcomes and actions taken.

### Update Audits in Progress



**1. Homeless Services**: The Office is wrapping up its second audit focused on homelessness in Oakland. The audit seeks to quantify the number of people placed in different shelter and housing types and the number of those receiving other homeless services; evaluate the performance of select contracted shelter

and service providers; identify disparities in how City-provided shelters and

related services are provided to various homeless subpopulations; and review the coordination and partnerships of agencies engaged in addressing homelessness in Oakland.

2. The City of Oakland's Building Permitting Process Audit Series: The objectives of this audit series are to 1) evaluate the internal controls over building permit fee processes; 2) evaluate building fees' alignment with the City's Municipal Code, State Law, and leading practices; and 3) identify the drivers of the surplus in the City's Development Services Fund.

The following audits are in progress:

**3. Recommendation Follow-Up:** The Office is wrapping up its inaugural recommendation follow-up process, which entails identifying all the relevant open audit recommendations made by the Office since 2010, determining the status of the recommendations (implemented vs. partially implemented vs. not implemented), and publicly reporting findings.

**4. Measures M and N:** The purpose of these mandated audits is to determine whether internal controls over revenue from voter-approved Measures M and N are in place and effective, and whether proceeds were properly disbursed as prescribed in the legislation. The scope of the audit includes Fiscal Years 2017-18, 2018-19, 2019-20, and 2020-21.
